## CAPCT PRESIDENT'S REPORT TO THE CAPCT ANNUAL GENERAL MEETING JUNE 13, 2023

Greetings CAPCT Members! It's time to report on the past year and it is my pleasure to share with you the highlights of 2022 – 2023.

This year, given that the CAPCT now has a Charitable Number registered in Canada (not only in Ontario) we have put this good news into an action and focused on humanitarian efforts. Specifically, in light of the disastrous earthquake in Turkey and Syria, the CAPCT created a Turkey Relief Project (TRP) to support clinicians in Turkey working with earthquake survivors.

In the first part of the TRP, CAPCT along with Robert Besner (the Esther and Bernard Besner Family Foundation) sponsored one volunteer member to go to Turkey to support their clinicians during this extraordinary time. This mission was successfully accomplished in April.

In the second part of the TRP, CAPCT provide an on-line series of nine seminars to clinicians in Turkey working with traumatized earthquake survivors. Upon completion of this series, several members offered to create a small support group for Turkish therapists dealing with complex trauma cases. Many thanks to the volunteering members who are offering their time and expertise.

This year again, CAPCT has been instrumental in promoting early interventions and teaching Infant-Parent Psychotherapy (IPP), a model developed by our members Elizabeth Tuters and Sally Doulis. We are grateful to Elizabeth and Sally for bringing IPP to CAPCT. We now offer Introductory and Advanced training in IPP through our Extension Program. Please note, a new series of 15 Introduction to IPP seminars is beginning this September 2023.

Again, as part of our humanitarian efforts, we are offering a fee reduction for the Introduction to IPP and the Advanced IPP courses for those Turkish therapists who are working with people devastated by the earthquake in Turkey and Syria.

This year's Extension Program was again made accessible to mental health professionals outside our association. This for-fee programming allows us not only to reach a wider audience and share our unique work with other professionals but allows our members access to international experts in the psychoanalytic field. Last year's programming expert was Beatrice Beebe and this coming Fall, in collaboration with the TICP, we will bring Miriam and Howard Steele to present on "Attachment throughout the Lifespan". Please watch for 'Save the Date' emails.

I would like to acknowledge that Robert Besner Besner (the Esther and Bernard Besner Family Foundation) has been responsible for making these events possible and we are grateful to him for this unique opportunity. His generous contributions, also allows us to offer a reduced fee to our Candidate



Members, to support their participation in our professional community events offered by the Extension Program.

The Continuing Education Programming, however, is free of charge to the members. The focus of this year's Continuing Education Program presentations will be on the theme of Adolescence. We plan to gather a series of case studies on the psychoanalytic treatment of adolescents from contributors around the world (including CAPCT members) in a volume called *Adolescent Casebook*, edited by Jack and Kerry Novick. Please stay tuned for further details.

Although the CAPCT and CICAPP collaboration has been quiet for the past few years, we continue to be open to working collaboratively.

I am happy to present to you the Report of the Nominations Committee and the slate of candidates who have been proposed for election at the Annual General Meeting. A group of seven experienced clinicians and psychoanalytic thinkers have accepted the nomination. We have two members to be newly elected, Lynda Phillips and Marcela Almeida – Welcome! We are looking forward to working together.

I wish especially to salute the Board Members who are the engine of our success in steering our association: Sandra Meyerovitz, Robyn Weddepohl, Elizabeth Tuters, and Robin Holloway – thank you for your time, unique ideas, and generosity – thank you with all my heart.

My gratitude goes out to Suzanne Pearen, our administrator, for her expertise and understanding of our needs. Suzanne makes our efforts seemingly effortless. Thank you Suzanne for your professionalism and dedication.

Further, I wish to thank Elizabeth Tuters for her work as Treasurer, and Suzanne Pearen for her oversight in the matter of our financial stability. Thanks in part to our Extension Programming we are standing on stable financial ground.

And I would like to thank you, the Members, for being part of this unique community of psychoanalytically minded thinkers and clinicians dedicated to serving infants, children, and adolescents.

## REPORT OF THE CAPCT FINANCE COMMITTEE TO THE CAPCT AGM JUNE 13, 2023

#### **Overall Fiscal Outlook**

We ended the fiscal year of Dec 31 2022 with a profit. In round figures, our 2022 revenues were \$87,600 and our expenditures were \$34,308 for a profit of \$24,127. CAPCT membership fees remain the same as in 2021. The investment fund is stable, and growth reflects the external factors at play in the economy during the covid recovery phase of global markets: high inflation, rising interest rates, and concerns about slowing economic growth globally.

#### **Revenue from Membership Dues and Events**

The fee for renewal of membership fees remained the same in 2022 (\$270 for clinical members; \$220 for Post-Academic Candidates; \$140 for Candidates). Membership dues in 2022 generated \$16,940.

Our continuing education programming has generated significant revenue in 2022. The continuing IPP education series has generated \$36,243.

CAPCT is the grateful beneficiary of a directed donation from the Esther and Bernard Besner Family Foundation in support of ongoing IPP and infant mental health programming.

#### **PEPweb**

The PEPweb fees charged to CAPCT members remained the same in 2022, at \$110 for clinical members and \$68 for candidate members. CAPCT currently subsidizes the cost of PEPweb fees; we are charged in U.S. dollars and the exchange rate differential is absorbed by CAPCT.

All CAPCT members are required to participate in the CAPCT PEPweb subscription unless they are already subscribed members via another institute or individually (university membership does not count). This is a requirement to maintain the CAPCT group subscription rate with PEPweb.

#### Administration

Suzanne Pearen continues to manage all administration functions including programming, bookkeeping and events/workshop management. She was off for several months in 2022 due to a medical leave but



has since returned to active status. The administration rate increased to \$37 per hour in January 2023.

CAPCT continues to consult with an investment specialist at Manulife Securities. As of March 31, 2023, the investment account has a current market value of \$43,165. The next quarterly statement will be provided after June 30, 2023.

#### **Charitable Status**

CAPCT received charitable status confirmation on April 29, 2022. An online portal for donation receipt management was created in February 2023 and is available on the CAPCT website and will be integrated into ongoing future outreach and fundraising efforts.

#### **Summary and Recommendations**

Our general financial situation is positive. The charitable status continues to generate new opportunities to grow outreach of continuing education efforts and increase membership levels. As always, we must remain vigilant in our approach to all expenses. Our streamlined administration and bookkeeping functions have maximized efficiency. We must ensure all workshops going forward are conceptualized and executed with profitability at the forefront.

We remain excited about the possibilities for improving our finances and membership levels in the upcoming year and believe there is good reason for continuing optimism.

### REPORT OF CATCH TO THE CAPCT AGM JUNE 13, 2023

We are currently funding sixteen treatment cases from ten different schools, located in Scarborough and downtown Toronto. We have seen an uptick of cases since we have been able to return to the schools and have started a waiting list for September. With the increase in requests and cases, we hope to increase our roster of therapists for the upcoming year.

We continue to work with Heather Briggs for ongoing social media management as well as for building strategic partnerships to share articles to increase awareness and we have launched a podcast series. The podcast is proving to be very successful; there are 31 episodes currently posted and to date, there have been over 4000 all time plays, including some international listeners. The website visits and social media activity continues to see increased traffic. Catch has approximately 1000 followers on Twitter and we have had some movement on Linked In.

Our Investment Committee continue to oversee the implementation of the investment policy and report to the Board on a regular basis. Thank you Wes for the amazing job you continue to do.
